## General Information For New Business



Listed below is general information to assist you in contacting the necessary State, County or City offices prior to opening a new or existing business.


## Zoning Verification

Whether you are building a new structure or using an existing structure for your new business or starting a home occupation, you will need to contact the Baldwin County Planning \& Zoning Department for a Zoning Verification.

## 2 <br> Purchase a Business License

City Business License - Contact or visit a City Hall in which your business is located. There may be requirements prior to opening your business, i.e. zoning, inspections, etc.

State/County Business License Contact or visit a Probate Office in Fairhope, Foley, Robertsdale or

Bay Minette. You will need to purchase a business license even though your business may be located within a City's corporate limits or police jurisdiction.

Please note - If purchasing an existing business, you may transfer a State/County Business License for a minimumfee.

Apply for Sales Tax, Consumer Use Tax and/or Lease Tax

State Sales Tax - Contact the Alabama Department of Revenue by phone (251) 344-4737 (Mobile) or (334)240-1490 (Montgomery), email or visit.

Example: If you are a retail store, you will need to contact the State prior to opening your business in order to apply for a "Sales Tax License" which allows you to purchase your goods wholesale.

The State has an online application that allows you to receive tax information in a shorter time frame.

Please note - If you are purchasing an existing business you will need to contact our office prior to the purchase of the business in order to obtain a "Good Standing Certificate" form. If the previous owner is not in compliance with the sales/use tax laws (delinquent), you may be personally responsible for the payment of these taxes.
